# **PREAMBLE**

These Rules and Regulations are intended to be a guide to the use of the Club Facilities. They are not intended to deal with all conceivable issues that may be presented for governance. These Rules and Regulations are established by the Club to protect the Club Facilities and to promote the health, safety, welfare and enjoyment of the members, their families and guests and all other persons using the Club Facilities. The Club is committed to providing all members and their guests with an enjoyable club experience. To uphold these standards, members and guests are expected to act in a manner consistent with good taste. The Club may amend these Rules and Regulations from time to time as it determines appropriate in its sole discretion.

#### **GENERAL CLUB RULES**

1. Members, their families and their guests shall abide by all rules and regulations of the Club as they may be amended from time to time.

The Club Facilities shall be open on the days and during the hours as may be established by the Club. Areas of the Club may also be closed for scheduled maintenance and repairs. Certain areas of the Club may be designated as "member only" facilities.

Performance by entertainers will be permitted on the Club Facilities only with the permission of the Club.

- 2. Dining room activities for groups will be permitted only with the permission of the Club.
- 3. Alcoholic beverages will not be served or sold, nor permitted to be consumed, at the Club in any manner prohibited by state or local law. The Club reserves the right, in its sole discretion, to refuse service to a member or guest when that member or guest appears to be intoxicated.
- 4. All food and beverages consumed on the Club Facilities must be furnished by the Club unless otherwise permitted.
- 5. Employees are permitted to deliver food or alcoholic beverages to locations away from the immediate area of the clubhouse or other designated areas of the Club only with the permission of the Club.
- 6. Commercial advertisements shall not be posted or circulated in the Club nor shall solicitations of any kind be made on the Club Facilities or upon the Club's stationery without the prior approval of the Club. Other than as permitted in writing by the Club, no petition shall be originated, solicited, circulated or posted on Club property.
- 7. Members shall not use the roster or list of members of the Club for solicitation or commercial purposes or distribute the roster to anyone other than a member.
- 8. It is contrary to the Club's policy to have its facilities used for functions or fundraising efforts for the benefit of a political cause, except as specifically permitted by the Club. The Club Facilities shall not be used in connection with organized religious services or other activities except as may be approved by the Club.
- 9. Members should not request special personal services from employees of the Club who are on duty or the personal use of the Club's furnishings or equipment which are not ordinarily available for use by members.
- 10. Dogs or other pets (with the exception of those assisting persons with disabilities) are not permitted on the Club Facilities, except with the permission of the Club. Where dogs are permitted on the grounds, they must be on a leash. Members are responsible for damage caused by an animal owned by the member or under the member's control.
- 11. All complaints, criticisms or suggestions of any kind relating to any of the operations of the Club or its employees must be submitted in writing, signed and addressed to the Club Manager.
- 12. Members and their guests may not abuse any of the Club's employees, verbally or otherwise. All service employees of the Club are under the supervision of the Club

Manager, and no member or guest shall reprimand or discipline any employee, nor shall a member request an employee to leave the Club Facilities for any reason. Any employee not rendering courteous and prompt service should be reported to the management of the Club immediately.

- 13. Self-parking is permitted in areas identified as such. No parking will be allowed on grassed areas. "No Parking" signs must be observed. Vehicles parked in violation of "No Parking" signs may be towed at the owner's expense.
- 14. Smoking is not permitted within 15 feet of the following areas; the restaurant, the proshop, the sales center, the recreation center, or the pool area. Smoking is permitted on the golf course; however, if dry conditions and fire danger are present, the Club may prohibit smoking on the course as well.
- 17. No fireworks are permitted anywhere on Club property or adjacent areas unless part of a fireworks exhibit organized and conducted by the Club.
- 18. Firearms and all other weapons of any kind are not permitted on Club property at any time.
- 19. Use of the Club Facilities may be restricted or reserved from time to time by the Club.
- 20. Violation of any of these rules or conduct in a manner prejudicial to the best interests of the Club will subject the person in violation to disciplinary action by the Club in accordance with these Rules and Regulations.
- 21. The personnel of the Club will have full authority to enforce these Rules and Regulations and any infractions will be reported to the management of the Club.
- 22. In no event shall the Club discriminate against any individual because of the individual's race, color, religion, sex, national origin, age, handicap or marital status.

## MEMBER DUES AND CHARGES

- 1. Members' dues will be billed on a monthly basis unless otherwise determined by the Club. Resident Members dues will be paid to the IPOA.
- 2. A member is entitled to charge privileges at the Club so long as his or her membership is in good standing and the Member has an active Credit Card on file with the Club. Cash payments may or may not be permitted as determined by the Club from time to time.
- 3. Members have the option of having dues, fees and other charges billed (at the time of purchase) to their credit or debit card on file with the Club, or billed directly to their club house account. Such charges will be billed on a monthly basis and members will receive a written statement of their charges via email on the first of the month. Members may choose to have their club house account auto-reconcile to the Credit Card on file on the first of the month or they may pay their bill by cash or check

by the tenth of the month. All members agree to pay directly to the Club any amounts not paid by the credit or debit card company within ten days of receipt of written notice from the Club. Any charges not paid by the Member by the tenth of the Month will be billed to the Credit Card on file. Dues only for a Resident Member will be paid by the Ironbridge Property Owners' Association.

- 4. The Club may require clubhouse minimums, in its discretion, which the Club may charge to the member's club account if the member does not charge such amount during each period.
- 5. Club accounts shall be deemed delinquent from the date first billed if payment is not received within 10 days after the date of the monthly statement. Past due bills will be subject to a \$30.00 late fee plus one and one-half percent (1.5%) interest on the overdue balance per month, but not to exceed the maximum amount permitted by law. The late payment charge shall accrue 10 days from the date of the monthly statement until the account is paid in full. Members having past due bills may be charged a reinstatement fee at the discretion of the Club to reactivate an account once it is deemed delinquent.
- 6. If a member fails to pay any club account within 10 days of when it is first billed, the Club shall have the right to suspend membership privileges in the Club at any time until the delinquent account is paid in full. Under no circumstances will a suspended member/membership have any rights or use of the club and its facilities. Continued delinquency for a period of 90 days from the date a club account is first billed or repeated incidents of delinquency by a member may result in termination of membership in the Club.
- 7. If the club account of any member is delinquent, the Club may at its option take whatever action it deems necessary to effect collection, including without limitation, suspension or termination of a membership or legal action. If the Club commences any legal action to collect any amount owed by any member or to enforce any other liability of any member to the Club, and if judgment is obtained by the Club, the member shall also be liable for all costs and expenses of such legal action and reasonable attorneys' fees, including any fees required in connection with appellate proceedings.
- 8. Cancellation. Members may choose to cancel their Membership after the minimum commitment agreed upon between the Member and the Club, at the time of signing, has been fulfilled. Members must supply the Club with 30 days notice to cancel their Membership.

#### **GRATUITIES**

1. For the convenience of all members, a gratuity percentage, as determined from time to time by the Club, may be added to all food and beverage sales. A member may increase the gratuity percentage by signing the ticket invoice and changing the amount of the gratuity as the member deems appropriate.

2. It is customary for the Club to send a letter providing an opportunity for members to contribute a suggested contribution to a Holiday Fund for all seasonal Club employees. Payment of such contribution will be voluntary and will be included on the contributing member's November bill. This Holiday Fund provides the members with an opportunity to show their appreciation to seasonal Club employees during the holiday season. Club management shall be responsible for the distribution of these funds.

## **CONTACT INFORMATION**

- 1. Each member shall be responsible for filing with the Club, in writing, preferably on a form provided by the Club, his or her mailing address, e-mail address and telephone number and any changes thereto, where the member wishes all notices and invoices of the Club to be sent. A member shall be deemed to have received email/mailings from the Club ten days after they have been mailed to the email/mailing address on file with the Club. In the absence of an email/mailing address on file at the Club, any Club mailing may, with the same effect described above, be addressed as the Club Manager may think is most likely to cause its prompt delivery.
- 2. The Club must be notified in writing of any change of address. Failure to do so shall constitute a waiver of the right to receive Club notices, bulletins and any other communications, and a violation of these Rules and Regulations.
- 3. The Club will not provide members' contact information to vendors or marketing firms.

# MEMBERSHIP CORRESPONDENCE

Complaints or suggestions concerning the management, service or operation of the Club should be in writing, signed by the member and addressed to the Club Manager. Errors in billing charges should be directed to the attention of the Accounting Department.

## **CLUB SERVICES AND ACTIVITIES**

- 1. The Club provides a variety of social, cultural and recreational events in which all members are encouraged to participate.
- 2. The Club encourages the use of Club Facilities by members for private functions. Members are requested to make reservations with the appropriate Club personnel for available dates and arrangements. Private parties at the Recreation Center will be scheduled at the Club's discretion, limited to two parties a month, Memorial Day to Labor Day, Monday thru Thursday, no Holidays, after 4 pm. Private parties will not be restricted during the off season (September thru May).
- 3. Private functions are permitted at the Club only with prior permission of the Club. The individual sponsoring the function shall assume full responsibility for the conduct of guests and the removal of any decor. The sponsor of the function shall be

responsible for any damage to the Club Facilities and for the payment of any charges not paid by individuals attending the private function.

4. Special events and functions may be scheduled from time to time at the discretion of the Club.

#### DISCIPLINE

- Members are responsible for their own conduct and for the conduct of their family members and guests. Any member whose conduct or whose family's or guest's conduct shall be deemed by the Club to be likely to endanger the welfare, safety, harmony or good reputation of the Club or its members or is otherwise improper, may be reprimanded, fined, suspended or expelled from the Club and have all privileges associated with the membership suspended or terminated by the Club. The Club shall be the sole judge of what constitutes improper conduct, but improper conduct will include, without limitation: (i) failing to meet eligibility for membership, (ii) submitting false information on the Membership Agreement, (iii) allowing his or her membership card to be used by another person or providing non-members access to member-only amenities, such as tennis courts, recreation center or pool, (iv) failing to pay any amount owed to the Club in a proper and timely manner, (v) failing to abide by the rules and regulations as set forth herein and as established by the Club from time to time, (vi) abusing Club personnel or employees, or (vii) acting in a manner incompatible with the standard of conduct of the existing membership or which would likely injure the reputation of the members or the Club.
- 2. Any member accused of improper conduct shall be notified of the Club's proposed disciplinary action and shall be given an opportunity to be heard by the Club to show cause why he or she should not be disciplined. If such member desires to be heard, the Club shall set a time and date (not less than ten days thereafter) for a hearing. While such complaint is being considered by the Club, the member shall enjoy the privileges of the Club. Notwithstanding the foregoing, the Club may, without notice and without a hearing, immediately suspend some or all privileges associated with a membership and/or, after notice, terminate a member for failure to pay in a proper and timely manner dues, fees or any other amounts owed to the Club.
- 3. The Club may restrict or suspend some or all of a member's, family member's and/or guest's Club privileges. If the Club determines that a member's conduct or the conduct of his or her family or guest is improper, the Club may expel the member, suspend or restrict the member's membership privileges, or restrict the use privileges of the member's family or guest whose conduct was improper. No member is entitled, on account of any restriction or suspension, to any refund of any membership deposit, dues or any other fees. During the restriction or suspension, dues and other charges shall continue to accrue and shall be paid in full prior to reinstatement as a member in good standing. Under no circumstances will a suspended member/membership have any rights or use of the club and its facilities.

# LOSS OR DESTRUCTION OF PROPERTY OR INSTANCES OF PERSONAL INJURY

- 1. Each member as a condition of membership and each guest as a condition of invitation to the Club Facilities assume sole responsibility for his or her property. The Club shall not be responsible for any loss or damage to any personal property used or stored on the Club Facilities, whether in lockers or elsewhere. Any such personal property which may have been left in or on the facilities for six months or more without payment of storage thereon may be sold by the Club, with or without notice, at a public or private sale, or may be otherwise disposed of, and the proceeds, if any, may be retained by the Club.
- 2. No person shall remove from the room in which it is placed or from the Club's premises any property or furniture belonging to the Club without proper written authorization.
- 3. Every member of the Club shall be liable for any property damage caused by the member, any guest or any family member. The cost of such damage shall be charged to the responsible member's club account.
- Any member, family member, guest or other person who, in any manner, 4. makes use of or accepts the use of any apparatus, appliance, facility, privilege or service whatsoever owned, leased or operated by the Club, including without limitation, the use of golf carts, or who engages in any contest, game, function, exercise, competition or other activity operated, organized, arranged or sponsored by the Club, either on or off the Club's premises, shall do so at his or her own risk. The member and his or her family members and guests shall hold Blue Heron Properties, LLC (the Company), any manager of the Club Facilities, their affiliates, their successors and assigns and their respective shareholders, partners, directors, officers, members, employees, representatives, agents and members of the Club's advisory Board of Governors or committees (collectively, the "Indemnified Parties") harmless from any and all loss, cost, claim, injury, damage or liability sustained or incurred by him or her, resulting from the use of the Club Facilities, including without limitation, the wearing of golf shoes with soft spikes or spikeless shoes, or otherwise, arising out of or incident to membership in the Club and/or from any act or omission of any of the Indemnified Parties, Any member shall have, owe and perform the same obligation to the Indemnified Parties hereunder in respect to any such loss, cost, claim, injury, damage or liability sustained or incurred by any guest or family member.
- 5. Should any party bound by these Rules and Regulations bring suit against any of the Indemnified Parties in connection with any event operated, organized, arranged or sponsored by the Club or on any other claim or matter in connection with membership in the Club, and fail to obtain judgment therein against any one or more of them, said party shall be liable to the prevailing Indemnified Parties for all costs and expenses incurred by them in the defense of such suit, including court costs and attorneys' fees and expenses through all appellate proceedings.

#### **CHILDREN**

- 1. The use of the facilities by children (under 18) will be determined by the Club from time to time. The Club may mandate children under 18 be accompanied by an adult member while utilizing certain club amenities.
- 2. Children under the lawful drinking age are not permitted in any lounge unless accompanied by an adult. Children under the age of 21 shall not be permitted to sit at the bar in the Restaurant.
- 3. Members are responsible for the conduct and safety of their children when enjoying the Club Facilities.

### **ATTIRE**

General Attire. It is expected that members will choose to dress in a fashion befitting the surroundings and atmosphere provided in the setting of the Club. It is also expected that members will advise their guests of the dress requirements. The Club may publish dress requirements from time to time. Gentlemen and ladies are requested to dress in a fashion compatible with the appropriate occasion. Shirts and shoes must be worn at all times when on Club Facilities. Bathing suits may only be worn in the pool areas. All other Club Facilities require appropriate cover-ups.

# Golf Attire. Proper golf attire is required for all players. Proper attire shall mean the following:

- 1. Men: Shirts with collars and sleeves, turtlenecks or mock tees (collar must be a minimum of 1 1/2" in height), slacks, tailored or Bermuda shorts (no greater than 4" above the knee) are considered appropriate attire. Tank tops, tee shirts, mesh shirts, sweat pants, warm-up suits, blue jeans, swim wear, short shorts, cut-offs, gym shorts, tennis outfits or other athletic shorts are not permitted.
- 2. Women: Dresses, slacks, skirts or shorts (no greater than 4" above the knee) and blouses are considered appropriate attire. Halter tops, tank tops, tee shirts, cut-offs, sweat pants, warm-up suits, blue jeans, swim wear, tennis dresses, short shorts, or other athletic shorts are not permitted.
- 3. Golf Shoes: Shoes with metal spikes are not allowed at the Club. Shoes with "soft spikes", spikeless shoes, or golf sandals must be worn by all golfers.
- 4. This dress code is mandatory for all players. Improperly dressed golfers shall be asked to change before playing. If you are in doubt concerning your attire, please check with the pro shop before starting play.

Tennis Attire - Proper tennis attire as determined by the pro shop is required at all times. Colors are permitted. Examples of attire not permitted are: T-shirts with graphic designs, undershirts, fishnet shirts, cut-offs, bermudas, jams, blue jeans, bathing suits, gym shorts, slacks and walking shorts. Regulation tennis shoes are required.

#### **GUEST PRIVILEGES**

Guest privileges may be extended under the rules established by the Club from time to time. Although it is the intention of the Club to accommodate guests without inconvenience to the members, the Club reserves the right to limit the number of guests that are invited or are sponsored by a member over the course of a membership year and the number of times a particular guest may use the Club Facilities in any given membership year. The Club shall establish from time to time the rate of the daily guest fees, charges and the rules and regulations for use of the Club Facilities by guests. Guest privileges may be denied, withdrawn or revoked at any time for reasons considered sufficient by the Club, in its sole and absolute discretion.

- 1. A member may bring guests to the club and accompany the guests in their use of the club facilities. An accompanied guest on the golf course must be in the same foursome as the member during the guests entire use of the facilities.
- 2. A member may also sponsor guests to use the Club Facilities unaccompanied by the member by making arrangements with the Club.
- 3. A particular individual using the Club Facilities as a guest must be registered by the sponsoring member with the Club. The Club reserves the right to require identification by each guest. The member will be charged guest fees for their guest's use of the Club Facilities as determined from time to time by the Club.
- 4. Guests will be entitled to use the Club Facilities only in accordance with the privileges of the membership of the sponsoring member.
- 5. Guest charges for any services can be payed by the guest or be charged against the sponsoring member's club account. Cash payments are permitted.
- 6. The sponsoring member shall be responsible for all charges incurred by the guest. The sponsoring member is also responsible for the conduct of a guest while at the Club. If the manner, deportment or appearance of any guest is deemed to be unsatisfactory, the sponsoring member shall, at the request of the Club, cause such guest to leave the premises of the Club.

#### **GENERAL GOLF RULES**

- 1. The Rules of Golf as adopted by the USGA together with the Rules of Etiquette as adopted by the USGA shall be the rules of the Club, except when in conflict with local rules or with any of the rules herein.
- 2. "Cutting-in" is not permitted at any time. All players must check in with the starter. Under no circumstances are players permitted to start play from residences.
- 3. Practice is not allowed on the golf course. The practice facilities should be used for all practice.
- 4. Speed of play: It is the goal of all players to complete their round in less than four and one half hours. This amount of time is more than adequate, provided all players remain aware of the rights of others to play without delay. It is the

responsibility of each group to keep pace with the group ahead. If a group falls one complete hole behind the group ahead, the group should allow the following group to go through. It is each group's responsibility to be observant of its position on the course and keep pace. The ranger has the authority to keep play moving at the proper pace for all players' enjoyment. Players unable to keep proper pace may be requested to leave the course.

- 5. If a player is repeatedly warned for slow play, the Club may take such action as it deems appropriate, including without limitation, restricting the person's use of the golf courses during certain times of the day.
- 6. All players who stop after playing nine holes for any reason must occupy the next tee before the following players arrive at the tee or they shall lose their position on the golf course and must get permission from the starter to resume play.
- 7. All tournament play must be approved in advance by the Golf Professional.

Enter and leave bunkers at the nearest level point to the green and smooth sand over with a rake upon leaving.

Repair all ball marks on the green.

Repair all divots.

Searching for balls other than those played by members of the group is not allowed on the course at any time.

Each player must have his or her own set of golf clubs.

Proper golf attire is required for all players, as previously described.

If lightning is in the area, all play shall cease. The Club does not assume any duty to detect lightning and warn members of lightning. If Club personnel do warn players about potential lightning in the area, players must stop play immediately.

Jogging, bicycling, or recreational walking is permitted on the golf course cart paths only during specified times. Check with the golf pro shop as these times will change throughout the year.

No beverage coolers are permitted on the course unless provided by the Club.

"Discontinued Play" Policy: less than three holes played - full 18 hole credit; less than 12 holes played - nine hole credit.

Twosomes may play at the discretion of the pro shop. Twosomes should not expect to play through foursomes and should not exert any pressure on the groups ahead. Foursomes shall have the right of way.

Twosomes and singles shall be grouped with other players, if available, at the discretion of the pro shop.

Singles shall have no priority on the golf course and shall be permitted to play only at the discretion of the pro shop. Singles should not expect to play through other groups and should not exert any pressure on groups ahead.

Groups of five or more players shall only be permitted on the golf course with the permission of the pro shop.

## **HOURS OF PLAY**

The hours of play and pro shop hours are printed on the monthly statements. The pro shop shall determine when the golf course is fit for play.

## **GOLF STARTING TIMES**

- 1. All players must have a starting time reserved through the pro shop. The staff shall assign the starting time depending on availability.
- 2. Starting times may be made in person, by phone during pro shop hours or online.
- 3. Starting time changes must be approved by the pro shop.
- 4. Players who fail to cancel their starting time one hour prior to their scheduled starting time may be charged a fee for the unused rounds as determined by the Club from time to time.
- 5. Members should notify the pro shop of any cancellation as soon as possible.

## REGISTRATION

- 1. All members and guests must register in the pro shop before beginning play and all members shall present their membership cards at registration.
- 2. Failure to check in and register ten minutes prior to a reserved starting time may result in assignment of another starting time or cancellation, at the discretion of the starter.

#### PRACTICE RANGE

- 1. The practice range is open during normal operating hours. All members must check in at the pro shop before using the practice range. Guests of members using just the driving range will be charged a per diem use fee. The practice range may be closed for general maintenance at the Club's discretion.
- 2. Range balls are for use on the practice range and may not be used on the golf course. You may not use your own golf balls on the driving range.
- 3. Golf carts are not permitted on any tee area. Parking of golf carts is allowed in designated areas.

- 4. Balls must be hit from designated areas. No hitting is permitted from the rough or sides of the practice range.
- 5. Proper golf attire is required at all times on the practice range.
- 6. Ball shaggers are not permitted.
- 7. Lessons by unauthorized professionals are prohibited.

#### **GENERAL GOLF CART RULES**

- 1. The use of golf carts is mandatory, unless approved by the pro shop prior to play. If a member or guest is permitted to walk, the member or guest must walk the entire round of golf, or the member or guest will be charged the applicable cart rental fee.
- 2. Golf carts shall not be used by a member or guest on the Club Facilities without proper assignment and registration in the pro shop.
- 3. Golf carts may only be used on the golf course when the course is open for play.
- 4. Golf carts may only be operated by persons at least 16 years of age having a valid automobile driver's license.
- 5. Only two persons and two sets of golf clubs are permitted per golf cart.
- 6. Obey all golf cart traffic signs.
- 7. Always use golf cart paths where provided.
- 8. Be careful to avoid soft areas on fairways, especially after rains. Use roughs whenever possible.
- 9. Never drive a golf cart in the native grass areas.
- 10. Never drive a golf cart through a hazard.
- 11. Operation of a golf cart is at the risk of the operator. Persons who are or appear to be legally intoxicated may not operate a golf cart. Cost of repair to a golf cart which is damaged by the member, a family member or a guest of the member shall be charged to the member. Each member and guest of the Club shall be held fully responsible for any and all damages, including damages to the golf cart, that are caused by the misuse of the golf cart by the member, his or her family members or guests or guests of the Club, and shall reimburse the Club and/or any operator of the Club for any and all damages the Club may sustain by reason of misuse.

- 12. Each member accepts and assumes all responsibility for liability connected with operation of the golf cart. The member also expressly indemnifies and agrees to hold harmless the Indemnified Parties from any and all damages, whether direct or consequential, arising from or related to the member's, his or her family members' or guests' use and operation of the golf cart.
- 13. "Course closed" or "hole closed" signs are to be adhered to without exception.
- 14. Violations of the golf cart rules may result in loss of golf cart privileges and/or playing privileges.

## **HANDICAPS**

- 1. Handicaps are computed under the supervision of the pro shop in accordance with the current USGA Handicap System.
- 2. All members and their guests with a USGA approved handicap may participate in Club tournaments. All handicaps submitted may be reviewed by the pro shop.
- 3. Members are responsible for entering all their scores on a daily basis. Any member failing to turn in a score shall result in a score being posted that is equal to their lowest score on record.
- 4. Accurate records are to be kept of scores turned in and recorded for all full rounds played.

# **GOLF COURSE ETIQUETTE**

Persons using the golf course should do their part to make a round of golf a pleasant experience for everyone at the Club. Here are some suggestions:

- 1. Do not waste time. Anticipate the club or clubs you may need, and go directly to your ball. Always be near your ball to play promptly when it is your turn. If a player is delayed in making his shot, it would be courteous for such player to indicate to another player to play which should not be deemed playing out of turn.
- 2. The time required to "hole out" on and around the green is a chief cause of slow play. Study and clear the line of your putt while others are doing the same. Be ready to putt when it is your turn.
- 3. Be sociable, but reserve your extended conversations for the clubhouse.
- 4. When approaching a green, park your golf cart on the cart path on the best direct line to the next tee, in order to save significant time. Never leave the golf cart in front of the green where you will have to go back and get it while the following players wait for you to move on.

- 5. When play of a hole is completed, leave the green promptly and proceed to the next tee without delay. Record the scoring for the completed hole while the others in your group are playing from the next tee.
- 6. If you are not holding your place on the course (see General Golf Rules), allow the players behind to play through. Do the same if you stop to search for a lost ball.
- 7. The golf rangers will report slow play and all breaches of golf etiquette to the pro shop. Appropriate action will be taken by the pro shop personnel.

## RECREATION CENTER SWIM &TENNIS FACILITY POLICIES

## GENERAL RECREATION CENTER POLICIES

- 1. Members, their families and their guests shall abide by all rules and regulations of the Club as they may be amended from time to time.
- 2. The Recreation Center shall be open on the days and during the hours as established by the Club management. Present Pool hours of operation are Monday through Sunday from 10:00 a.m. to 8:00 p.m. and 4:00 a.m to 10:00 p.m. for the Fitness Center. The Club may change hours of operation as needed. Areas of the Recreation Center may be closed from time to time for scheduled maintenance and repairs.
- 3. Alcoholic beverages will not be served or sold, nor permitted to be consumed, at the Recreation Center during hours or at locations prohibited by law. No alcoholic beverages will be sold or served to any person not permitted to purchase the same under the laws of the State of Colorado, or any applicable ordinances or regulations. All alcoholic beverages consumed or otherwise possessed on the Recreation Center facilities must be sold and purchased at The Kitchen at Ironbridge. Persons may not remove alcohol from the Recreation Center facilities. The Club reserves the right, in its sole direction, to refuse service to a member or guest.
- 4. Members should not request personal services from employees of the Recreation Center who are on duty or the personal use of the Recreation Center's furnishings or equipment which are not ordinarily available for member's use.
- 5. Dogs or other pets are not permitted on the Recreation Center's facilities.
- 6. All complaints, criticisms or suggestions of any kind relating to any of the operations of the Recreation Center or its employees must be in writing, signed and addressed to Club Management
- 7. Members and their guests may not abuse any of the Club's employees, verbally or otherwise. All employees of the Club are under the supervision of the Operation's Manager. No member or guest shall reprimand or discipline any employee, nor shall a member request an employee to leave the Club's facilities for

any purpose whatsoever. Any comments regarding an employee not rendering courteous and prompt service should be reported to the Club's Operations Manager immediately.

- 8. Management reserves the right to remove involved parties from the facility who are engaging in behaviors that are destructive to property, against policies set forth for use of the Recreation Center, unsafe to fellow members or in other ways disruptive to staff, members, and/or the intended nature of the facility. In such instances where inappropriate behavior continues, Member or guests may have their Club privileges revoked or suspended for period of time as determined by the Club's Operations Manager.
- 9. The entire Recreation Center is a NO SMOKING facility. This includes all play areas, courts, Fitness Center, and pool areas.
- 10. Absolutely no fireworks or sparklers are permitted anywhere on the Club's facilities or adjacent areas unless part of a fireworks exhibit organized and conducted by the Club.
- 11. Firearms and all other weapons of any kind are not permitted at the Club's facility at any time.
- 12. No member, visitor or guest is allowed in the service or restricted areas of the Recreation Center.
- 13. Use of the Recreation Center facilities may be restricted or reserved from time to time by the Club.
- 14. The Club reserves the right to amend or modify these policies, as it determines appropriate from time to time, and will notify the membership of any change.
- 15. The personnel of the Club and Recreation Center have full authority to enforce these rules and any infractions will be reported to the Club's Operations Manager.

## RECREATION CENTER FACILITY USAGE

- 1. Members are responsible for his/her self, family and his/her guests for understanding all policies and procedures of the Recreation Center. The member is also responsible for any financial purchases that he and his family, or guests may incur.
- 2. Member must be present with guests at all times.

An adult (18 years of age or older) must accompany and supervise children under the age of 14 when utilizing the swimming pool.

Members may bring guests for a fee. The adult rate is \$15 and the child rate is \$10 per daily visit. These fees will be charged to the accompanying members. This is a no cash facility. All goods and services must be paid through the member's account.

A nanny or baby-sitter (18 and over) is allowed to utilize the Recreation Center at no charge when accompanied by the child member of a family and has written or verbal approval from the adult member. If parent(s) is present a guest fee will be charged for the nanny or baby-sitter.

### POOL HOUSE AND FITNESS CENTER ACTIVITIES

- 1. The Pool provides a variety of social, cultural and recreational events in which all members are encouraged to participate.
- 2. Special functions may be scheduled from time to time at the discretion of the Club.

#### **IRONBRIDGE POOL POLICIES**

- 1. Members, their families and their guests shall abide by all rules and regulations of the Club as they may be amended from time to time.
- 2. Use of the pool at any time is at the swimmer's own risk. Any injuries or accidents should be reported to the Club staff immediately. Use of the pool may result in certain unforeseeable risks. The Club shall not have any liability to any member, or guest of a member, for damage or injury resulting from use of the pool facilities. The Club is under no obligation to have a lifeguard or a lifeguard with specific training in the pool facilities.
- 3. All swimmers must shower prior to entering the pool and hot tub.
- 4. Only proper swimming attire is permitted in the pool area and cut-offs are prohibited. Parents or guardians may wear street clothes with rubber-soled shoes when they are present to supervise their children or attend lessons.
- 5. Bathing suits are not permitted in the Golf Pro Shop or the Clubhouse. All bathers must dry off before entering the Pool. Bathers are encouraged to wear coverups when in the building.
- 6. Rafts and other flotation devices may be allowed at the pool attendant's discretion. No jumping off the sides of the pool onto flotation devices or kickboards. No jumping off of slide and surrounding structure.
- 7. Only Alcohol purchased through the Club may be brought onto premises. Beer and wine is available. Please see pool attendant.
- 8. The Club strongly suggests moderation with alcohol consumption around the pool. A two drink limit is encouraged.

- 9. Food and gum are not allowed in the pools or hot tub. Food is allowed only in designated areas of the pool facilities.
- 10. Bottles, glass objects, drinking glasses and sharp objects are not permitted in the pool area. Trash should be placed in the proper receptacles located throughout the pool area.
- 11. The pool will be closed by the pool staff during inclement weather. Pool staff will reopen facility when weather conditions permit. Swimming is permitted only during designated hours. The pool is officially closed when a "CLOSED" sign is posted.
- 12. Caution should be used when walking on wet floors and pool decks.
- 13. No running is permitted in the pool area.
- 14. No animals, skateboards or rollerblades are allowed on the premises.
- 15. Diving is not permitted.
- 16. Lifesaving and pool cleaning equipment should be used only for the purposes intended.
- 17. Fishing, spear fishing and snorkeling equipment, other than a mask and snorkel, are not to be used in the pool area except as part of an organized course of instruction.
- 18. Radios, televisions and the like are permitted only when played at a sound level which is not offensive to other members and guests.
- 19. Persons who leave the pool area for over 30 minutes must relinquish lounges and chairs by removing all towels and personal belongings. Saving chairs for persons absent from the pool area is prohibited.
- 20. Children who are in diapers or are not potty-trained must wear swim diapers.
- 21. No Lifeguard will be on duty in the pool area. A parent MUST ACCOMPANY children who use wading pool and/or Water Spray Garden and must keep his/her child in view at all times.
- 22. When going down the slide, the person must slide down feet or knees first. No head or back ¬first slides.
- 23. No flotation devices are to be taken down the slide.
- 24. No horseplay in the waiting line at top of slide. No running up the stairs.
- 25. No climbing on or near rocks that surround the slide. No walking or running up the slide.

- 26. Only one individual may use the slide at a time (parents with toddlers excepted). Individuals must wait until the person using the slide is off the slide and clear of the landing area.
- 27. Members and Guests are responsible for any damages to property of the Recreation Center. Recreation Center privileges may be suspended for violation of any of the above policies at the discretion of the Club management.

## **TENNIS POLICIES**

- 1. The Rules of Tennis of the USTA shall apply at all times, except when in conflict with the local rules or with any of the rules herein.
- 2. Members, families and their guests shall abide by all rules and regulations of the Club as they may be amended from time to time.
- 3. All Members must sign-in at Pro Shop. This is necessary for accounting and security purposes.
- 4. Guest fees will be \$5.00 per adult per court time and \$2.50 per child under the age of 18 per court time. All guests must register at the Pool House. Guest fees will be directly billed to the member's account
- 5. The front desk personnel at the Pool House will make all court reservations Memorial Day thru Labor Day and the proshop at all other times. Members may make court reservations 72 hours in advance. Players may not "double book" courts on the same day (two court times- different opponents, unless prior approval is obtained from the Club.
- 6. Court Times other than peak times are one (1) hour for singles play and one and a half-hours (1 ½) for doubles play. Playing time may be extended if court is not reserved, however court must be relinquished, upon request, to players that have not utilized a previous court time.
- 7. Cancellation of court times are encouraged a minimum of 4 hours in advance of scheduled time.
- 8. Individuals, under the age of 18 years during prime hours, depending upon court demand, may have restrictions imposed on them as to court use.
- 9. Proper tennis attire as determined by the Club is required at all times. Colors are permitted, but cut-offs, Bermudas, jams, bathing suits, mesh shirts, tank tops, gym shorts, sweat pants, slacks and running shorts are not permitted. Required attire includes collared shirts for men and tennis coordinates for women. Regulation tennis shoes are required. All guests are expected to adhere to the dress code.
- 10. Proper tennis etiquette should be observed at all times. Excessive noise, racquet throwing or profanity will not be permitted at any time.

- 11. Skateboards, bicycles, roller skates, roller blades, etc., are not permitted on the tennis courts. DOGS ARE NOT ALLOWED AT ANY TIME.
- 12. Use of the tennis courts shall at all times be subject to the control of the Club. The Club may reserve courts for special events when needed.
- 13. The tennis facilities may be closed when necessary for maintenance operations or when dictated by safety considerations as determined by the Club.
- 14. The Club staff may implement temporary rules during peak play periods as deemed necessary.

## FISHING RULES

- 1. Fishing in the golf course lakes, when approved, is for members and guests only.
- 2. All members must check in with the Golf Pro Shop prior to fishing and identify which location they will be fishing at.
- 3. The rules as established by the Colorado Division of Wildlife are incorporated herein by reference. Members are required to abide by these rules.
- 4. Members must observe all state and local laws concerning river and fishing activities.
- 5. A fishing license is required for persons 16 years or older who desire to fish at the Club in accordance with Colorado laws and regulations. Fishing licenses are available from the Colorado Division of Wildlife. This only applies to river fishing.
- 6. Children under 16 years of age are not required to obtain a fishing license but must observe limits and all other fishing regulations. The bag limit, however, is half the daily bag limit except when the bag and possession limit is one. This only applies to river fishing.
- 7. Children under 16 years of age can take the full daily bag and possession limits if they purchase a fishing license. This only applies to river fishing.
- 8. A licensed angler does not need to accompany a youth.
- 9. Fishing licenses are not transferable.
- 10. It is illegal to take any threatened or endangered species.
- 11. All fishing on golf course ponds will be catch and release ONLY.

- 12. All fishing on golf course ponds require the use of barbless hooks ONLY.
- 13. Fish caught and placed on a stringer in a container or live well, or not returned to the water immediately, count towards the daily bag or possession limit when fishing the river.
- 14. Fish that are released immediately will not count towards the daily bag and possession limit when fishing the river.
- 15. Fish must be released immediately into the same water where it was caught when fishing in golf course ponds.
- 16. Proper fishing etiquette should be observed at all times. Remember that your activities may affect other fishermen.
- 17. Safety precautions must be observed when fishing. All persons who fish at the Club do so at their own risk. The Club is not responsible for the safety of members and their guests during fishing and river activities.
- 18. All members and their guests will respect the property rights of others when fishing the river as there are several areas along the river where neighboring property abuts Ironbridge Club property. These areas are clearly marked with signage and in some cases fencing. In particular, nearby Ironbridge lots 63 thru 69 are areas that have been marked with the appropriate signage.
- 19. All guests must be accompanied by a member when fishing at Ironbridge Golf Club.

## FITNESS CENTER RULES

- 1. The Fitness Center is for members only. Access cards are NON-TRANSFERRABLE.
- 2. Use of equipment is at your own risk. You are responsible for knowing your own physical abilities and limitations.
- 3. Proper use of the equipment is your responsibility.
- 4. Please no wet bathing suits or bare feet in the fitness center.
- 5. Report faulty equipment to the golf pro shop staff or by calling 384-0630.
- 6. Return equipment and accessories back to their proper place.
- 7. Appropriate gym dress required this includes clean clothing and athletic shoes.
- 8. Children under the age of 16 must be a ccompanied by a responsible adut 18 years or older.
- 9. For security and safety, this facility is monitored under 24-hour video surveillance.
- 10. A \$25 fee will be assessed to replace a lost access card.
- 11. Please wipe down all equipment and accessories after use.
